# This is Explorers Academy!

Becoming Explorers Academy in 2017, we continue to provide early childhood education in Yellowstone and Carbon counties. A Head Start program, Explorers Academy offers quality early education in the community by employing proven developmental techniques that increase the chance for student success in school. Never a one-size-fits -all approach, our program identifies distinct needs of each child as well as those of the child's family *and* works to nurture and further develop academic and social growth and sustainability. Explorers Academy is a preschool system tailored for childhood success and preparation for kindergarten.

# THOSE WE SERVE

As a Head Start program, Explorers Academy serves the most vulnerable children and their families in Yellowstone and Carbon counties, giving them a place in their community to succeed.

# Income Eligibility

The majority of children admitted to Explorers Academy are from families whose income is at or below the federal poverty line. It is a requirement for us to offer enrollment to these children first.

#### Foster Children

Also automatically eligible for our program are foster children; regardless of their foster family's income. We served 60 (11%) foster children this year alone!

### Public Assistance

If a family receives, or would qualify to receive in the absence of childcare, public assistance benefits, their children automatically qualify for our program.

# **Experiencing Homelessness**

Children from families that are currently experiencing homelessness are automatically eligible for the Explorers Academy program. We also assist in securing housing for these families!

#### With Disabilities

At least 10% of enrollment slots are reserved for children with disabilities.

## FAMILY SERVICES

Here at Explorers Academy, we believe that children's parents are their most important teachers. By this belief, and with a focus on each child's learning and overall success, we partner with community agencies and refer families to various community resources. We also offer classes and workshops for our families (all of our Family Services staff are certified in *The Incredible Years Basic Parenting* program). ## **LEADERSHIP**

Head Start programs, such as Explorers Academy, are guided by a governance structure that includes a Board of Directors, a Policy Council, and a management staff. Not only does this structure ensure that Explorers Academy meets and properly tends the community's needs, it also allows for parents to have a voice in decision making.

# **Board of Directors**

A dynamic group of community members volunteering their time and expertise on a monthly basis, our board of directors always includes: an accountant or financial manager; an early childhood education/development specialist; an attorney familiar with issues pertaining to those we serve; members with children currently or formerly enrolled in our program; and members with expertise in education, business administration, or community affairs.
