At Head Start Inc., it is our mission to ensure that all of our children leave us ready for kindergarten life lona success. and classrooms are led by highly qualified educators, who value the uniqueness of each child in their care. Each classroom follows the Montana State Early Learning Objectives and Head Start Early Learning Outcomes. Our teachers use a variety of research based curriculum including Creative Curriculum, Handwriting without Tears, Heggerty Phonics, Step to ensure Second our students are receiving a high quality early childhood education.

Creative Curriculum, our main curriculum, is a comprehensive, research-based curriculum that features inquiry, exploration, and discovery as the foundation of all




learning. As a content-rich, developmentally appropriate curriculum, it delivers academic rigor alongside social-emotional learning and cognitive development. Creative Curriculum brings meaningful interactions and learning to life in classrooms. Each month, our teachers change out their classroom environment, providing opportunities for students to explore a variety of concepts and themes, as they take on new roles from baker, to florist, to veterinarian. Our teachers know, when students are curious about what they are learning, they are more likely to be active participants in their education.

Heggerty Phonics lessons are taught alongside Creative Curriculum each day with explicit teacher modeling and scaffolded support. Through Heggerty Phonics, students learn to play with language and hear the sounds in spoken words—a preliteracy skill needed in kindergarten.

EDUCATION

In addition to our curriculum, all our students participate in developmental screenings to identify individual areas of strength and growth. Teachers, in collaboration with families, use these screeners to develop individualized learning goals for each child. Understanding that parents are a child's first and most important teacher, our teachers strive to create relationships with parents, and guardians to ensure that all our students are able to thrive both at home and at school.



Thanks to our dedicated, highly qualified teaching staff, and curriculum, our program truly provides high quality early childhood services that prepare our students for kindergarten and beyond.



Family Advocates meet regularly with parents to provide assistance and ongoing support towards reaching their goals.

(Lower numbers are still due to some effects of COVID)




Received yearly well-child **Dental** Exams.

FAMILY SERVICES

ERSEA provides the backbone of all Head Start services. ERSEA stands for Eligibility, Recruitment, Selection, Enrollment, and Attendance.

Community Assessment data provides a foundation for ERSEA practices within our program, ensuring we are serving the children who will benefit from Head Start's comprehensive services the most.

During the 2021-2022 program year, less children were served (320) than what Head Start, Inc. is funded for (360). Flexibilities offered by the Office of Head Start have given programs like ours the ability to adjust to local health conditions. The impact of COVID-19 in our community has impacted child enrollment for services, as well as workforce to meet programmatic needs.



FAMILY SPOTLIGHT

Nate Little Owl will never forget going through one of the most experiences he has ever endured. Grief is not something often talked about and is often hard to deal with when addressed. This would eventually lead Nate into a drug addiction that overtook his life for many years, which lead him into a destructive lifestyle he never thought possible. To cope, Nate turned to drugs. He thought it was better to be high than experience the pain he was going through. During that year of hard times, Nate and his wife Angelica had their children removed by CPS and placed with a family member. Nate states, "In that moment I felt defeated. I thought to myself, what is the point of going on when our kids were already taken from us."

January 30th, 2016 is a day Nate and Angelica will never forget. After exhausting all help from family and friends, they finally hit rock bottom. They were living in their car, freezing from below zero weather, strung out on meth, realizing no one was going help them. In that moment they both knew changes needed to be made. The next morning was the beginning of their journey towards sobriety. This was "day one" of leaving the past behind and planning a better life for themselves and their children. This would not be an easy process, but they knew that it was worth the battle.

While working to get clean and get their kids back, they faced numerous obstacles. When asked about the process Nate said "The first step was to make sure we had a safe place to go and then we reached out to our CPS case worker. We wanted to do it right." This led them to the Yellowstone Family Drug Court. "There are 5 phases of drug court that must be completed. Every Thursday we had to do a UA to make sure we hadn't been using. We were also completing the drug court requirements, as well as attending classes. Additionally, we completed an outpatient program through the Mental Health Center, and we were required to complete individual programs."

FAMILY SPOTLIGHT

They began having supervised visitation with their kids. Nate said the visits started out with seeing them for an hour or two, then it progressed to full days, and eventually they were allowed to spend the night. Nate and Angelica also had goals to obtain such as finding employment and adequate housing.

Fast forward to March of 2018, Nate and Angelica received news that the CPS case was officially closed. Nate stated, "It felt great knowing that CPS was no longer involved and that we got to be a family again." Their oldest daughter had previously attended the Head Start program.

"Head Start did such wonderful things for our oldest, and we couldn't wait to enroll our other kids. The staff were wonderful, and the teachers were amazing."

Nate had been working in the hotel industry. In December of 2021 he saw a maintenance position posted on the Head Start website. Knowing he was looking for a change in employment, he decided to apply. He has loved working for Head Start ever since. Fall of 2021 was an exciting time because his youngest daughter started her first year at Head Start. Nate has expressed his appreciation for his Family Advocate, stating that she has helped them in several ways, such as bringing them a Thanksgiving meal and cold medication while they were all sick and by just being there when needed. "Our Family Advocate has helped us so much, especially during Covid. It was a great comfort knowing we had her support during that time."

Through it all Nate and Angelica have achieved so much since making the decision to live a stable and sober lifestyle. With the support of friends and family, Nate and Angelica have just celebrated their 7th sobriety anniversary. "It has been such an amazing feeling knowing our goals are being achieved. Head Start has helped our children in a variety of ways and continue to support us to help us reach our goals."

Head Start, Inc. is dedicated to promoting Oral Health through high-quality dental education, screenings, and daily hygiene habits. From daily tooth brushing in classrooms to high-quality nutrition services, Head Start children build healthy oral hygiene habits at a young age. For the last five years, Head Start, Inc. has partnered with Bright Smiles Dental Hygiene Services to provide on-site preventative services including dental screenings, fluoride treatments, and oral hygiene instruction and education.

Meet Melissa: Melissa Utley is a Registered Dental Hygienist and the founder of Bright Smiles Hygiene Services. Melissa has been providing preventative oral care services to under privileged populations, such as older adults and young children, in Yellowstone County for over 12 years.



Why did you start Bright Smiles? "I have always loved helping our community and working with children- so putting those together was perfect match. I saw a need for mobile dental hygiene services in our community, especially for older adults and young children who are not able to get to a dentist office on their own."



Why did you chose to partner with Head Start, Inc. to provide dental hygiene services? "I love working with kids and I love Head Start. I believe in the Head Start mission and program. The way Head Start prioritizes overall child well-being, including dental health, makes it easy to provide services for children in the program. What Head Start does for children and families is truly amazing. I wish all children in our community could be in Head Start!"

Why is dental health important during the early childhood years? "The mouth is the gateway to the body; if your mouth isn't healthy the rest of your body isn't healthy either. For kids, dental health can affect their development both physically and emotionally. Children with oral health concerns often show decreased speech, eating habits, physical growth, and social emotional regulation. Children experiencing pain may have difficulty focusing and participating in the classroom, making it hard for them to learn new skills."



Receiving regular dental screenings and treatment during early childhood helps prevent oral health concerns and decreases the likelihood of cavities. The Bright Smiles and Head Start partnership allows dental professionals, like Melissa, to come to the school to work with high risk children. Exposure to dental care when children are young helps set them on the path for better oral health as adults. They will be less likely to experience anxiety or fear about receiving dental care and more likely to seek out dental care as they age. "Children who have not received dental care may be fearful or anxious about doing a dental screening. I like to make screenings as welcoming and fun as possible to help them feel

comfortable. Sometimes a child is not comfortable having me complete their screening. When this happens, they will often at least sit in the chair and talk with me or watch a peer complete a screening. The next time they see me they will likely be more comfortable and willing to participate. The earlier children start learning about and being exposed to dental hygiene the better their chance to continue healthy habits throughout their life time. I love Head Start because children get oral health exposures and education at school with their teachers and peers giving them a have a higher chance of retaining it."
